**Your display table may not go beyond the 6' designated table area. If your display is larger than 6', you will be required to pay for 2+ tables to accommodate your display. Please make sure you fill in the correct number of tables on the registration form to avoid confusion.**

To ensure that all interested FMHA members have a fair chance at obtaining a display table, the following guidelines have been established:

- Current FMHA members will have the first option to obtain a display table; non-members must join the association to be eligible for a display table.
- Tables are \$225 each for FMHA members for the duration of the Convention (does not include audio/visual requirements, electric services, etc.). Exhibitor fees must accompany your completed exhibit registration form. Exhibit fees do not include Convention registration.
- Tables will be awarded on a first come/first served basis and table placement will be assigned by a random drawing.
